

April 2023 Business Meeting -Michael Roznick, GTRCC Secretary

Ben brought the meeting to order at 7:02. 11 members were present.

**President's Report –** Ben reminded members of upcoming events. The AMA sanction has been submitted for the Warbird event on June 24th, no word yet on approval. The sanctions have also been submitted and approved for both the SPA (June 10) and the Heli Fly In (May 20).

**Treasure's Report -** Frank Cox gave the Treasurer's report. He presented the Beginning Bank Balance, listed Monthly Income, Expenses, and earmarks. After all income and expenses, he gave the available cash which showed that the club remains in good financial shape.

**Vice-President's Report –** Reminded members to send notice of any minutes worked at the field to be recorded for maintenance credits.

**Secretary's Report –** Minutes from the March meeting were published in the newsletter.

**Safety Officer's Report –** Members were reminded not to turn off your radio with the aircraft powered on. This resulted in an unintentional takeoff and subsequent crash after an aircraft failsafed in a full throttle state. No people or property were damaged, but it resulted in destruction of the aircraft.

#### **Old Business**

Randy reported that the red mower wouldn't start last week. The yellow mower started fine. Randy is planning on investigating the issues further.

Ben updated members on container pricing. 20 ft containers were going for \$2800. He was unable to find 40ft containers. Frank was able to locate 40 ft containers in the \$2000-3000 price range. Frank still had the number of the person we originally obtained the container and will see if he has any available. Members approved a \$3000 budget for purchase of a new container. If available, Frank will have it delivered direct to the field.

Jason discussed the possibility of a 3D Fly in and will discuss this with potential sponsors and propilots to gauge interest. Still in work.

#### **New Business**

Frank discussed the need for Trophies for the SPA Event. He is looking for donations to cover this cost. Members are advised to look for and refer any potential sponsors to Frank.

Randy discussed opening a group of dedicated individuals to keep the field mowed. He proposed that members involved with this regular (estimated 2X per month) mowing group would have their dues fully covered by the club. Attendance would be logged to ensure all those participants will be covered. A Motion was made to approve a group of 4-6 individuals to have their dues covered. The motion was approved unanimously.

Frank mentioned that a field maintenance day should be completed prior to the helicopter event on May 20th. A field maintenance day was proposed for May 13th. Ben will also investigate getting someone to level the ground where the 2nd container may go. Frank also made a motion to rent a loader to prepare the dirt. A budget of \$400 was approved.

Ben mentioned that the club received a generous donation of RC aircraft and parts. These include some biplanes and WW1 aircraft models. These can be used for raffle prizes.

New member Ali has joined the club and is getting his son into the hobby. They mostly fly drones and FPV. He is assembling a fleet to do drone light shows and has 60+ drones. He has also offered a \$300 donation to the SPA event in exchange for advertising his business.




# Member's Projects
